

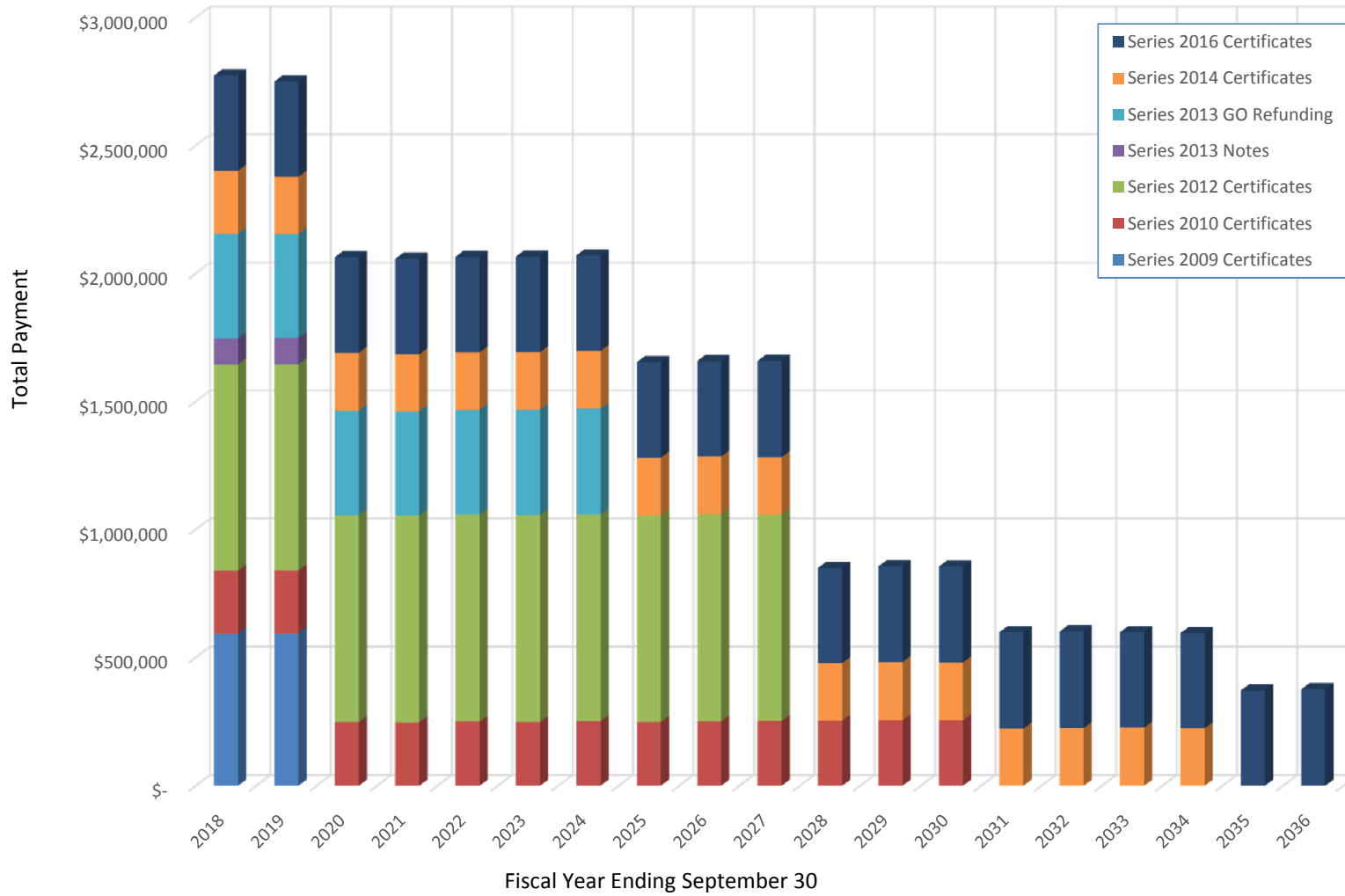

Combined Issues - Aggregate Annual Payments By Fiscal Year



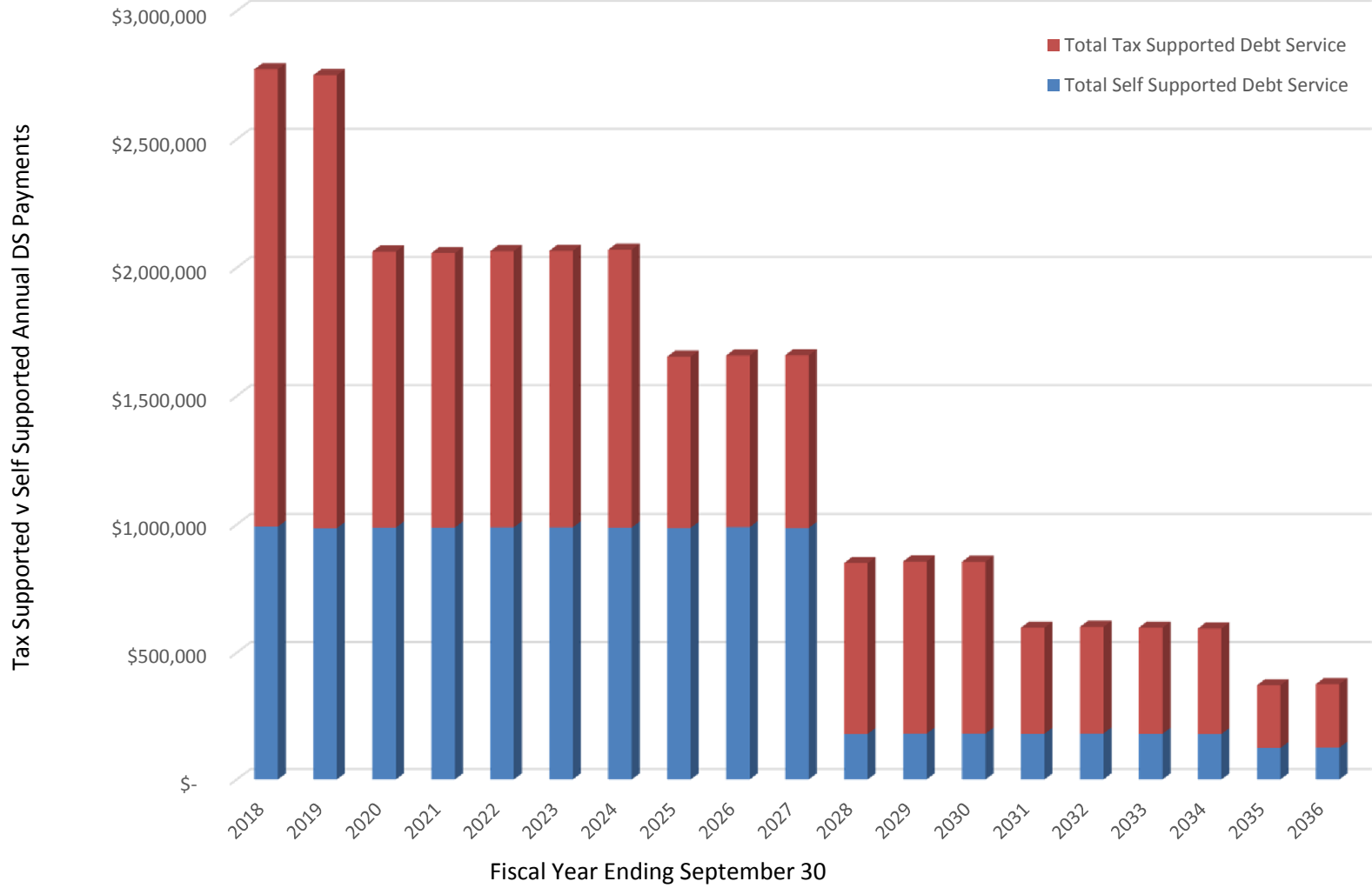
